The Legislative Update was Called to Order by President DeMarco at 12:15 p.m. The session was turned over to Legislative Committee Chairman Robin Schott who introduced FASNY Legislative Liaison David Sweet and FASNY Legislative Representative Peter O'Connell. Also present was New York State Assembleman William Nojay who represents Livingston and parts of Monroe and Steuben Counties.

Chairman Schott reported that the New York State Fire Service Organizations met in December 2012 to set their joint Legislative agenda. The full text and explanations of the Legislative items maybe found on the FASNY website: <u>www.fasny.com</u>

Also addressed was "Mark's Law" which has passed and stiffens penalities for causing injury or death to firemen, EMS and first responders. This is a part of the SAFER act.

FASNY Legislative Liaison David Sweet addressed remarks on the lack of funding for "required" training. Legislative Update conference concluded at 1:15 p.m.

President Anthony DeMarco Called the Regular Meeting to Order at 2:05 p.m. Assistant Sergeant-at-Arms Thad Gilbride pointed out the exits and then led the membership in the Pledge of Allegiance to the Flag. Chaplain Alan Way offered the Invocation. President DeMarco welcomed everyone to the meeting. A Motion to accept the Minutes of the previous session was made by William Kershner, Seconded by Alan Way. Carried.

Report of Secretary Timothy Tyrrell: Dan and I have been working every Tuesday at the office cleaning up old files and eliminating excessive paperwork. Dues notices have been sent to all fire service organizations and individual members. To date, we have received \$4500.00 in dues from 130 organizations and 192 members. We have a list of delinquent fire companies that we could use help in contacting. Jerry Gehrig and Jonathan McKnight have helped on this. There are five fire companies that have resigned from WNYVFA several fire companies are no longer listed on County lists. In 1999 we had 351 member fire companies and 2300 individual members. Dan has been working on the life member list. We have reduced the "missing" to just under 220 from an original fully paid 20 year life member list of 2100. The deceased members have been transferred to the Honor Roll and corrected addresses have been placed on the Active list. Our membership is dwindling. About 100 members will be removed from the Active list because they are deceased or dues notices have been returned as undeliverable. We have collected some back dues. Last year we had about 20 new members join WNYVFA. We need to get a membership drive underway, especially for fire companies. Dues are an important part of our income. There are 186 fire companies in the 11 Counties that are not members of WNYVFA.
